Proposed Law for Non-Ionizing Radiation Limits

Ballot Committee: *RadLimits at LastTreeLaws.com*

- **Monitor cell tower radiation** with one engineer per county
- **Limit wireless & electrical radiation** to the minimum necessary for operation
- **Allow non-wireless utility meters** (analog)
- **Make disabling wireless easy**
- **Invest in public wired infrastructure** for internet & phone
- **Create a 2-year commission to study health impacts** including small business & major unions
- **Set a 2-year ban on *most* new cell towers & street antennas**
- **Hard-wire public buildings & reduce radiation in schools, college**

Support Wireless & Non-Ionizing Radiation Limits

Because radiation from electricity and wireless can be dangerous, many countries set allowable exposures far below the US and limit exposures. **The US FCC has ignored a 2021 court order to reexamine exposure guidelines** based on current science *and* reported harm, *because* industry does not want to maintain public wired infrastructure (*despite getting annual subsidies to do so*).

Yet, the science shows we're all getting sick from exposures. UWA Prof. Emeritus Henry Lai reviewed about 2,500 relevant studies on non-ionizing radiation, including wireless and strong fields from electricity, published from 1990 to 2023. **70% to 91% of studies showed significant effects** such as related to altered gene expression, neurology, oxidation, genes, reproduction and development.

Public wired infrastructure is needed because placing powerful cell tower antennas on street poles by homes *instead* is dangerous. These '5G' antennas exceed federal legal guidelines, causing heating *besides* existing non-thermal effects, such as disrupting the orientation and migration of birds & butterflies.

Common Symptoms of Electromagnetic Sensitivity (EMS)	
fatigue, chronic and intermittent	headaches
pain, including muscle pain	skin reactivity, lesions
nausea, dizziness	insomnia
food sensitivity	confusion, memory loss
mood changes (e.g. anxiety, jumpiness, irritation, depression)

PETITION INSTRUCTIONS

DO NOT make ANY other marks. DO NOT STRIKE OR LINE MISTAKES. If you make a mistake, just use another line. *Extra marks, even coffee stains, invalidate petitions.*

1. Only 1 town may be listed on a petition!
2. Sign as registered and, for ID, print your name, too.
3. Print your street and number (and apt.# if any).
4. Leave blank the ward and precinct (prec.).

MARRIED – sign your own name (e.g. Mary Smith, not Mrs. John Smith)

PHYSICALLY DISABLED only – may authorize another person to sign for you

FOLDING is fine.

INSTRUCTIONS TO CIRCULATORS AND SIGNERS

- DO NOT ALTER THIS INITIATIVE PETITION IN ANY WAY. ADDITIONAL MARKINGS ON THIS PETITION WILL DISQUALIFY ANY SIGNATURES ON THIS PETITION SHEET.
- For your signature to be valid, you must be a registered voter in the city or town named below and your signature should be written substantially as registered. DO NOT sign the same petition more than once.
- If you are prevented by physical disability from writing, you may authorize some person to write your name and residence in your presence.
